Dear Minister,

Glasgow Statement on International Public Support for the Clean Energy Transition

We refer to claims that Export Finance Australia (EFA) is in discussions with Kumul Petroleum to finance a \$1.1 billion stake, off Santos, in the ExxonMobil-led PNG LNG project in Papua New Guinea ('PNG LNG').

We note that, under the Climate Change (consequential amendments) Act 2022, Export Finance Australia, in performing its functions, must have regarded Australia's commitments under the Paris Agreement, which includes limiting global warming to no more than 1.5 degrees above pre-industrial levels.

Australia's international partners, particularly our Pacific Island neighbours, have repeatedly called on the Australian government to increase its climate ambition and to end fossil fuel subsidies. Australia's Foreign Minister and Minister for Climate Change and Energy recently took a welcome leadership role in UN climate talks where a major topic of discussion was climate financing to help developing countries to transition away from fossil fuels to cleaner energy. In taking such a role, Australia acknowledged that supporting our development partners to grow their economies for the benefit of their people must go hand in hand with addressing the climate crisis that puts lives and livelihoods at risk.

We urge you to reaffirm Australia's commitment to the Paris Agreement by signing the Glasgow Statement on International Public Support for the Clean Energy Transition. This week alone we have seen Canada and New Zealand make significant steps towards decarbonising their export credit agencies by announcing they will sign the Glasgow Statement. If Australia refuses to join many of our developed country partners and trading partners in signing the statement, it will undermine the Australian government's seriousness in facilitating global efforts to limit global temperature rise and catastrophic climate change. It will also be a tangible demonstration of Australia's commitment to leading global ambition on climate action - a commitment the world will be seeking from a country that wishes to host a UN climate conference.

We would welcome an opportunity to discuss the benefits to Australia of signing the statement.
